

UAE Labelling requirements



Equipment or its packaging and user documentation must be clearly labelled with the label specified, unless otherwise agreed with the TRA in specific cases.

On an exceptional basis, the TRA may require that the label be applied to the equipment, regardless of whether or not the packaging and user documentation is marked.

The label shall not be used as a mark of quality or be used in any other way that is not intended by the TRA.

New Zealand / Australia Labelling requirements

Provided a supplier has an office or an agent in New Zealand, the supplier can apply to the Ministry for a New Zealand supplier code number on products. A list is available of those persons allocated a Supplier Code Number. The supplier code consists of the letter "Z" followed by a number. (Note: a supplier code, issued by the Australian Communications Authority (ACA) to suppliers based in Australia, is prefixed by the letter "N").



Lebanon Labelling requirements

The type approval labels are exclusively produced by the regulator TRA. They will not accept labels made by manufacturers or third party. The Importer should purchase the labels from the TRA upon receiving the Type Approval Certificate. Moreover, a specific size of the label will be made by the TRA however if the equipment is very small then as convenient size of the label can be provided.

Regarding the fee of the labels, The TRA will provide the importer with the number of labels requested in the Type Approval application. The charge of the labels is symbolic and price per unit will be communicated upon deciding on it.

The format of the Type Approval label for each of the RTTE classes and the NIE is as follow, the mentioned number is the TA certificate number or the importation license number for class 0 RTTE



Moldova - Rules for using National conformity mark SM

1. National conformity label (mark) SM applies on industrial products (hereinafter - product) from regulated field that the manufacturer or its representative, based in the Republic of Moldova (hereinafter - the producer or his representative), who applied or which is responsible for the product labeling has verified compliance with all essential requirements of its applicable technical regulations and the product been subjected to conformity assessment procedures.
2. National conformity label SM is formed of the letters S and M, respectively symbolize "safety as essential requirements" and "Moldova". Graphic symbol of the national conformity label SM is shown in figure 1.

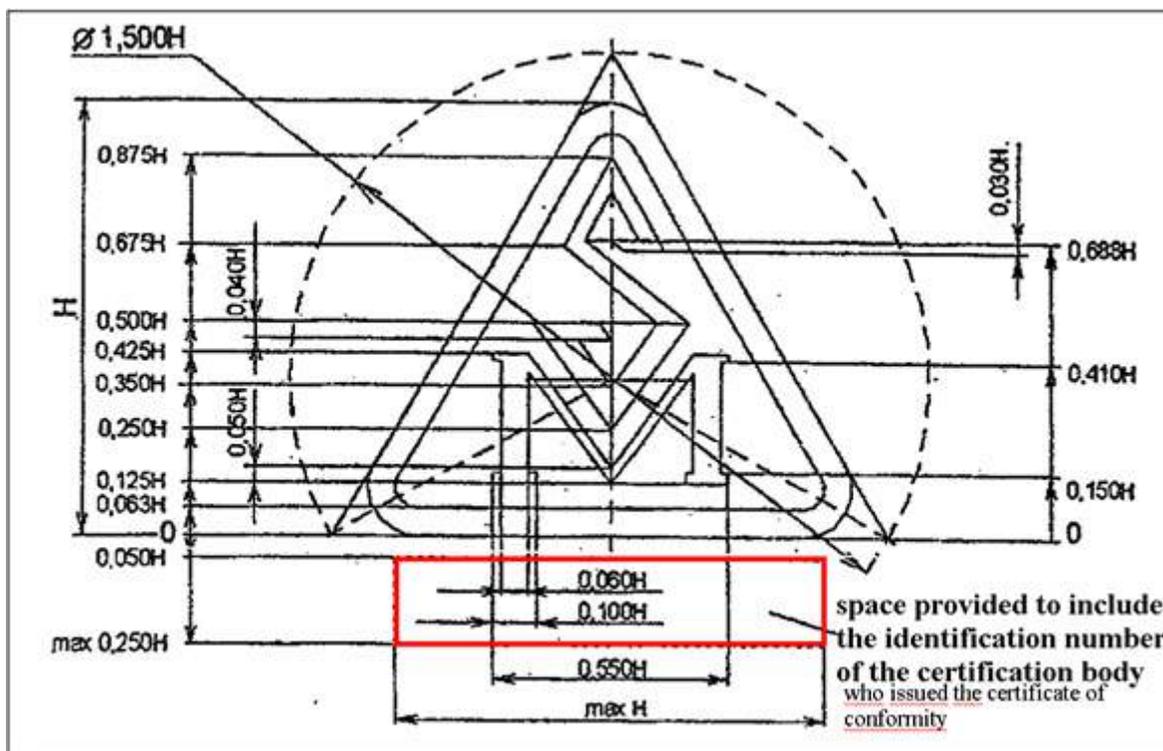


Figure 2. The dimensions of the national conformity label SM

3. The dimensions of the national conformity label SM must correspond exactly to those specified in Figure 2. (

Labelling Model:



South Africa

All type-approved telecommunication equipment, facility or radio apparatus shall have a legible label permanently affixed to the outside of such equipment, facility or radio apparatus, bearing

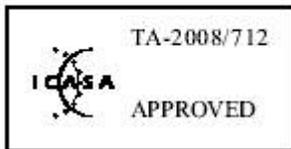
- (a) The ICASA logo and
 - (b) The ICASA issued licence number.
- (2) The label must be affixed before the product is made available for sale or lease or is supplied in any other manner.

The container in which the equipment, facility or radio apparatus referred to in regulation 3 is supplied shall bear a similar label.

- 5. The minimum size of the ICASA logo shall be 3 mm high by 3 mm wide.
- 6. Labels may be obtained from the Authority upon payment of the applicable fee.

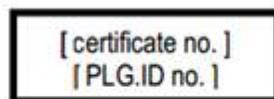

South Africa ICASA Label

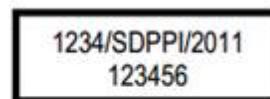


Indonesia

Labels are required for all equipment that is approved for use in Indonesia. The manufacturer is responsible for producing the label and affixing it to the equipment. The label must display the two key pieces of information, The number of the certificate and the PLG.ID number which can be obtained from the certificate. The size of the label just has to be visible by the bare eyes, the label can be placed in the user guide and/or packaging if there are size restraints. Marking colour and font size can be the choice of the manufacturer, there is no restriction. Please see the below label example.
